

## CIVILWAR

A Superhuman Registration Act has been passed which requires all people possessing paranormal abilities to register with the government. Those who do not register are considered criminals. Some heroes, such as Iron Man, see this as a natural evolution of the role of superhumans in society and a reasonable request. Others view the Act as an assault on their civil liberties. After being called upon to hunt down fellow heroes in defiance of the Registration Act, Captain America goes underground and forms a resistance movement.

After a brutal battle, Bill Foster--the anti-registration hero known as Goliath--has been killed. Other members of Captain America's resistance have been captured and brought to the pro-registration faction's holding facility in the Negative Zone. Both sides have retreated in order to regroup and plan their next move.

Many heroes have been left injured, discouraged and questioning where they stand. While some of Captain America's allies have joined with Tony Stark, Spider-Man is beginning to question his loyalty to Iron Man--and the Invisible Woman and the Human Torch have left the pro-registration side and gone in search of Cap's underground, officially breaking up the Fantastic Four.
